MINUTES OF MEETING OF EMERGENCY COMMUNICATION DISTRICT

BRENTWOOD, TENNESSEE

The Emergency Communications District Board met on Monday, April 27, 2020 at 7:00 pm at Brentwood City Hall.

Mayor Little stated the following:

"As you may know, Governor Bill Lee issued Executive Order 16 on Friday, March 16. This Order was issued to ensure that government continues to function openly and transparently during the COVID-19 emergency while taking appropriate measures to protect the health and safety of citizens and government officials. In his Order, Governor Lee recognized that guidance from the White House and Centers for Disease Control and Prevention advises that Americans should avoid social gatherings in groups of more than 10 people and that older persons and persons with serious underlying health conditions should remain at home. The Governor also emphasized that in the interest of limiting the community spread of COVID-19, private and governmental entities of all types should eliminate large public gatherings and conduct business remotely by electronic means to the greatest extent possible. The Order provides that governments may meet to conduct essential business by electronic means when the governing body determines that doing so is necessary to protect citizens.

Sadly, COVID-19 is spreading rapidly throughout the state and Williamson County, with known cases in Brentwood. Therefore, the City has determined that in the interest of protecting the health, safety, and welfare of Tennesseans and the citizens of Brentwood, it is necessary for the Emergency Communication District to meet partially electronically rather than in-person. We have posted the link for public viewing on the City's website and social media pages, and we have disseminated the same to the media.

Is there any objection by the Board? Seeing none, we will proceed with our meeting in accordance with the State of Tennessee Governor's Executive Order Number 16."

ECD Quarterly Revenue and Expense Report

Background

Financial Reporting

Please find attached the fourth quarter of fiscal year 2020 revenue and expense report for the Emergency Communications District (ECD) Fund. This report shows unaudited budget to actual comparisons for the twelve months of the 2019-2020 fiscal year.

Year to date revenues collected as of June 30, 2020 are \$1,463,897 or 102% of budget. Year to date expenses are \$1,435,043 or 101% of budget. For comparison purposes, for the same twelve month period for fiscal year 2019, revenues were \$1,573,647 or 110% of budget, and expenses were \$1,451,476 or 103% of budget. The difference between FY 2019 and FY 2020 year-to-date revenues is partially due to ECD having received excess operational funding equal to \$173,384 in FY 2019, but only received \$86,763 in FY 2020.

At a Glance

- The week of April 12th 18th was recognized as National Public Safety
 Telecommunications Week. Despite the Coronavirus pandemic, a week to
 recognize Brentwood ECD was in order. The team celebrated with casual themed
 dress days and meals were donated throughout the week.
- Recruitment for the 12th Public Safety Dispatch position was held. In all, there
 were 49 applications received and a conditional job offer was made.
- Congratulations to Dispatcher Kelli Hicks and her husband, Weston, on the birth of their beautiful baby girl, Savannah Ann. Savannah was born on June 9th.
- Brentwood Police Officer Destin Legieza was killed in the line of duty on June 18th as the result of a motor vehicle accident. Williamson County Emergency
 Communications Center handled all Brentwood ECD operations from 12:00 PM
 June 23rd 5:00 AM June 25th in order for all Brentwood Public Safety Dispatchers to attend the visitation and funeral services. We are ever grateful for the partnership we share and their assistance during this time of mourning.
- A retirement reception was held for Brentwood Assistant Police Chief Tommy Walsh for his dedicated service to the community for over 31 years.

OPERATIONS REPORT FOR Q2 – APRIL – JUNE 2020

A. Staffing

- Communications is currently staffed with eleven (11) full-time Dispatchers and one (1) Supervisor. Three (3) staff members are Lead Dispatchers and two (2) are Communications Training Officers (CTO's).
- A contingent job offer was made to fill the 12th Public Safety Dispatch vacancy.
 - Stacy Shotwell is currently in the background process. She has no previous Public Safety Dispatch experience.
 - Andrew Patton continues to work on an as needed part-time basis. We are very grateful for his service.

B. Statistics

Reports to substantiate the below statistical highlights are available upon request.

- Total calls answered (9-1-1 and Admin) 8,679
- E9-1-1 CALLS 1,869
- On average, calls were answered within 4 seconds (about 1 ring).
- Approximately, 84% of our 9-1-1 calls came from cell phones, which are significantly more difficult to locate than a traditional landline.
- The busiest hour of the day was between 4:00 p.m. and 5:00 p.m. The slowest hour of the day was between 3:00 a.m. and 4:00 a.m.
- The average telephone conversation lasted 87 seconds.
- Total CAD responses created 6,833

Police Department – 5,422

Fire & Rescue - 925

Non-Dispatched CAD Calls – 486

C. Medical Quality Assurance

 NFPA Standard 1221 recommends all medical calls are dispatched to responders within 90 seconds of call receipt. This quarter, Communications met this standard 98% of the time.
